Context

The 2030 Agenda for Sustainable Development offers decentralized cooperation the potential to harmonize and strengthen its vision and actions towards more equitable territorial development.

Andalucía is a region of Spain committed to foster territorial cohesion as well as international solidarity and cooperation. Its model of development cooperation has demonstrated great capacity to mobilize institutions, knowledge and local and regional experiences through long-term partnerships. It has provided results in a proximity basis and served as catalyst to address rising inequalities. However, challenges remain.

Across Europe, cities and regions are looking at the Agenda 2030 as a framework to strengthen the dialogue and coherence of international cooperation policies, proposing more inclusive, transparent and effective cooperation modalities. Based on these experiences, the session will discuss how the 2030 Agenda presents an opportunity to address shortcomings that are still

inherent in development cooperation models, and to what extent such findings are applicable to the overall decentralized cooperation modality.

Relevance

In line with the EDD's overall theme and sub-topic on understanding the structural causes of inequalities as well in the territories, the session aims to address the main question of how the 2030 Agenda can become an opportunity to rethink decentralized cooperation into a truly transformative SDG based territorial partnership model, thereby furthering territorial cohesion and equality in partner territories.

The main idea is to provide enough theoretical and practical elements to present how decentralized cooperation can shift from more traditional development projects into a networked and process-based approach that transcends actors, levels and sectors.

Outcomes

Participants will learn key elements on how the alignment and harmonization between decentralized cooperation actors, in place of origin and of action, can be promoted through the 2030 Agenda lens. Special attention will be paid to i) foster effective alignment towards locally SDG driven strategies and plans, as well as how to ii) increase integration with other development partners.

Johannes Krassnitzer, Coordinator of the ART Initiative, United Nations Development Programme (UNDP)

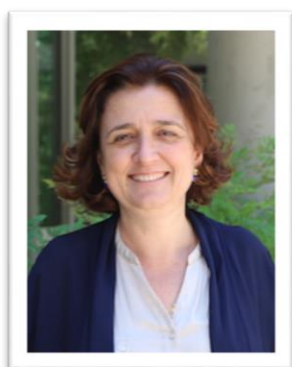

She has been professor of applied economics and international relations at the Loyola University of Andalusia and holds a PhD in Business Studies from the Faculty of Economic and Business Sciences (ESEA). Her research focus on the field of development and the fight against poverty through the analysis and study of institutions and development policies. From 2008 to 2011, she worked as a researcher and consultant for the Spanish Agency of International Cooperation for Development (AECID) and the Secretary of State for International Cooperation of the Government of Spain. From 2001 to 2007, she was a member of the Follow-up Committee

of the Code of Conduct of the Spanish NGO Coordinator. She regularly collaborated with numerous NGOs, including: Intermon Oxfam, Entreculturas and Intered. In 2001, she was an expert member of the Development Cooperation Council and part of the working group on education for development. She is also a founding member of the Spanish Network of Researchers for Development (REEDES).

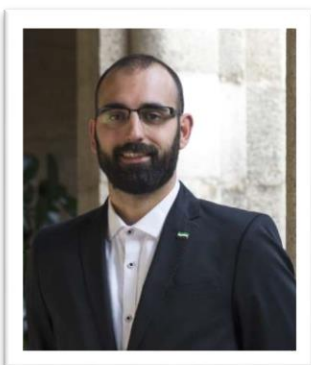
Gabriel Ferrero, General Director of Sustainable Development Policies of the Ministry of Foreign Affairs, European Union and Cooperation of Spain
